#### Accreditation Committee activities

A meeting of the Committee was held on Monday 15 OCTOBER 2018. Outcomes include:

- Approval of intern and PGY2 posts at Bass Coast Health (PGY2) and St Vincent’s Hospital Melbourne (intern term).
- The Report of the re-accreditation survey visit to Ballarat Health Services in August 2018 and their responses to survey report from Western Health and Wimmera Health Care Group.
- Advice of staffing and supervision changes at Bendigo Health and Grampians Intern Training.
- Review of mid-cycle accreditation reports (and junior doctor feedback) at Albury Wodonga Health and Peter MacCallum Cancer Centre.
